



Human Rights Commission of Sri Lanka

Public Notice

We have received information that the Human Rights Commission of Sri Lanka (HRCSL) is displaying nameplates, running fake offices, and using vehicles with such nameplates and VIP logos.

It has been revealed that these fake groups are carrying out illegal activities such as violating traffic laws, transporting illegal goods, illegally influencing the police in custody in police stations, and charging money by claiming to provide various services.

The Human Rights Commission of Sri Lanka is an independent commission established by the Constitution of Sri Lanka. The Human Rights Commission of Sri Lanka was established under the Human Rights Commission of Sri Lanka Act No. 21 of 1996. There is no charge for the services provided by it and in addition to the head office in Colombo, the relevant services are provided through 10 regional offices and 03 sub-offices island-wide.
