Performance Report - 04th Quarter, 2017 (October to December 2017)

Introduction

The Human Rights Commission of Sri Lanka (HRC) was established in 1996 by the Human Rights Commission of Sri Lanka Act No. 21 of 1996. The Act sets out the legal basis and operational principles of the HRC. The HRC is referred to in the Constitution of Sri Lanka but it is not formally established by the Constitution. The Chairperson and Members of the Commission are appointed under Constitutional provisions.

The Act defines the HRCSL's jurisdiction in terms of fundamental rights and human rights. Fundamental rights are certain civil and political rights as well as economic, social and cultural rights guaranteed in Chapter III of the Constitution of the Democratic Socialist Republic of Sri Lanka. Human rights are defined in international law.

The statutory functions of the Commission are:

- to inquire into, and investigate, complaints relating to procedures, or infringements or imminent infringements of fundamental rights to ensure compliance with the provisions of Constitution and to provide for resolution through conciliation and mediation
- to advise and assist the government in formulating legislation and administrative directives and procedures to promote and protect fundamental rights
- to make recommendations to the Government to ensure that national laws and administrative practices are in accordance with international human rights norms and standards
- to make recommendations to Government on the subscribing or acceding to treaties and other international human rights instruments
- to promote awareness of, and provide education in relation to, human rights. (Section.10 of Act No. 21 of 1996)

The Commission functions with 154 staff members. The Commission consists of Inquiries & Investigations, Education & Special Programmes, Research & Monitoring and Administration & Finance Division and 10 regional offices (Ampara, Anuradhapura, Badulla, Batticaloa, Jaffna, Kalmunai, Kandy, Matara, Trincomalee and Vavuniya) to carry out its functions. Each Division is headed by a Director and each Regional Office is headed by a Regional Coordinator. The Chairperson and/ or a Commissioner/ Commissioners supervise each Division and Regional Offices.

Special Activities During the Quarter

- Technical Training Program and Advocacy Training Program on Access Rights of Disabled persons was conducted in collaboration with the Australian Human Rights Commission for selected government officials, civil society representatives, and HRCSL staff from 14th to 17th November 2017 at Colombo.
- The Commission introduced a new general email address to HRCSL (sechrcsl@gmail.com)

- The Chairperson of HRCSL advocated on the revision of abortion laws in the country and stressed that the public policy on health matters should not be formulated solely on the basis of religious views.
- The Commission called applications for the recruitment of Directors and Translators of HRCSL.
- The Commission issued a press statement on negative publicity on HRCSL's intervention regarding expulsion of a school girl from a public school in Madatugama, misleading and discouraging the public from making complaints to HRCSL. Further, the Commission expressed concern on responsibility of media in providing correct information and providing assistance to build a human rights culture.
- Chairperson of HRCSL released a statement to mark International Human Rights Day 2017. The HRCSL in collaboration with Sri Lanka Arts Council organized an exhibition under the theme 'The First Human Rights Art Festival 2017'. Regional Offices conducted celebrations on the theme for Human Rights Day 2017.

Recommendations to the Government

- The Commission submitted its observations and recommendation to His Excellency the President on the International Convention for the protection of All Persons from Enforced Disappearances Bill by letter dated 28.09.2017 and posted it on HRCSL website on 06.10.2017.
- Pursuant to *suo-motu* action to protect the right to education of a school girl expelled from a public school in Kekirawa in the North Central Province an inquiry was conducted on 20.10.2017. The Commission subsequently issued a detailed recommendation to public education authorities on the need to take disciplinary action in schools in compliance with rights of the child.
