Providing Uninterrupted Power Supply During GCE Advanced Level Examination

This refers to Commission letters (Ref: PUC/LIC/2023/CEB/03, PUC/LIC/2023/CEB/04 & PUC/LIC/2023/CEB/05) dated 19th January, 21st January and 22nd January, 2023 on the above subject and to the agreement (Ref: HRC/RM/M/02/2022) made on 25th January 2023 by Ministry of Power and Energy, Public Utilities Commission, Ceylon Electricity Board and Ceylon Petroleum Corporation on the recommendation of Human Rights Commission of Sri Lanka to provide an uninterrupted power supply during the period of Advanced Level Examinations held until 17th February 2023.

The Commission has observed that the Scheduled Power Interruptions have been imposed on 25th January 2023, despite the above agreement.

In this context, the Commission will not approve any scheduled power interruption from 26th January 2023 (today) until 17th February, 2023 and the Commission direct you to provide an uninterrupted power supply until 17th February 2023, in accordance with the above agreement.

Further, be informed that the Commission will take necessary legal actions for violation of Condition 30 (10) of Electricity Transmission and Bulk Supply License No. EL/T/09-002 under the Provisions of Sri Lanka Electricity Act No. 20 of 2009 and Public Utilities Commission of Sri Lanka Act No. 35 of 2002, upon failure to adhere to the above.
